SAVE THE DATE FREE NURSE TRAINING

The Rehabilitation Research and Training Institute (RRTI) has received funding from the federal Health and Human Services agency to present 5 professional development programs for nurses, starting in January 2010. The courses will focus on pharmacology and telemedicine for individuals with developmental disabilities.

All of the training will be offered statewide via video-conferences held at over 15 OMRDD Developmental Disabilities Service Offices (DDSOs) at no cost to nurse participants.

The first half-day program will be on January 27, 2010 (9:00-12:00) and is entitled *Pharmacology and Developmental Disabilities: Practical Considerations for Nurses*. The course will be taught by Eileen Trigoboff, RN, APRN/PHM-BC, author of several textbooks on nursing and pharmacology.

Designed for nurses who are involved in assessing the medical status of individuals with developmental disabilities, the training program will cover practical information related to; assessment and intake, communication with patients and caregivers, rationales for behavior changes, and available pharmacology options, including strategies for administering and monitoring medications. Nurses will receive NYSNA contact hours.

The Training You Offer Today Just May Save a Life Tomorrow

"..if not for the actions taken by the staff at the time of the incident, she likely would not have survived."

That is exactly the situation in which staff found themselves on September 17th, while attending a agency CPR training course in NYS.

A colleague, also attending the training course, had just answered a question posed by the instructor when she suddenly fell face first, unconscious, on the floor from her seat. Another staff person, - a First Responder immediately sprang into action to attend to his fallen colleague. Another attendee, was an active participant using his medical military training to assist.

The colleague appeared to be having a heart attack and the First Responder called out to someone to call 911 and get the AED machine. Both staff members noticed that the individual's breathing was quick & garbled and immediately realized she needed CPR.

According to the staff members, the AED on site worked perfectly. After placing the machine's pads on the woman, the men followed the AED's directions, continuing to give her CPR, as directed by the machine. When the woman stopped breathing, and her pulse could no longer be detected, the AED instructed the men to shock the victim. They were able to shock her twice before emergency responders arrived.

Once EMS and the fire department arrived and hooked the woman up to their own AED, the woman was shocked one more time before her pulse returned and she began to breathe again. She was then transported to a local hospital where an emergency room doctor at the hospital told the woman's family that if not for the actions taken by the staff at the time of the incident, she likely would not have survived.
